

OFFICE ORDER

On the basis of recommendations given by the Standing Affiliation Committee (SAC) in its report dated 30-7-16 for affiliation of trade of Universal Pvt. III (Chanda Colony, Patiala road Patan Dist. Patiala) and its meeting held on 1-8-16, to recommend the affiliation of following trade of the Universal Pvt. III (Chanda Colony, Patiala road Patan Dist. Patiala) and its approval of SAC-Comm. a SCVT dealing with affiliation the SACVT will be granted. On the basis of the SACVT, the final affiliation order will be issued.

The unit shall be subject to the following conditions -

1. The unit will follow all the instructions issued by the Department.
2. The unit will strictly implement the rules and other orders regarding the affiliation of training, training fee etc.
3. That the affiliation is purely provisional for the first year, the standard and quality of training imparted by the Centre will be assessed by inspecting officers.
4. That the Centre shall fulfill the duty of staff strictly keeping in view the prescribed norms of SCVT, also available on the website www.punjabnmgov.in of the Department as and when there occurs a vacancy of staff. The Centre will maintain the Department about this affiliation within the 21 days of closing date of admission. The Department will carry out the inspection in this regard there after. If after this inspection the centre is found to be deficient of staff (qualifications & numbers) action for disaffiliation will be initiated against the centre.
5. That apart from the staff, any other deficiency of equipment/furniture, etc. addition or repair of building reported by the SACVT or otherwise as per the norms (available on website) will be fulfilled by the centre within 21 days of the closing date of admission. The Department will carry out the inspection in this regard there after. If this inspection the centre is found to be deficient of any thing from the stipulated norms, action for disaffiliation will be initiated against the centre.
6. That the centre will deposit/submit a security guarantee in the form of FDR pledged to the Parent - Technical Education & Industrial Training (IT Wing) Punjab, as per the following table before the start of the admission.

The centre will make admission in only those trades/units (seats) about which the affiliation order/letter has been issued by the Department. The total seating capacity (first and second year) of the centre, at any point of time will never exceed than the seating capacity for which the affiliation order/letter has been issued by the department this year or earlier.
