Establishment/Employers of Government, Public Sector undertakings and Private Industries (which include Punjab State Boards, Corporations, Municipal Corporations, Municipal Committees) whose occupations falls under the schedule of different designated Trades of Apprentice Act 1961, are liable to engage apprentices according to prescribed norms. All establishments must register themselves on apprenticeship portal www.apprenticeshipindia.gov.in and can also advertise the vacancies in the local, regional newspapers, electronic media and approach local employment exchanges, nearby Industrial Training Institutes to engage apprentice and also upload the vacancies/opportunities on the web portal www.apprenticeshipindia.gov.in.

Govt. of India has also launched National Apprenticeship Promotional Scheme (NAPS- 2) to encourage more MSMEs to engage Apprentices. This scheme supports the establishment covered under the Apprentice Act 1961 and shared 25% of the prescribed stipend subject to a maximum of Rs 1500/- per month directly to apprentice by Gol through DBT as per NAPS-2 guidelines. The stipend support would not be given during the basic training period for fresher candidates. A public web portal of MIS application www.apprenticeshipindia.gov.in is available to engage the apprentices & to allow timely and transparent flow of information. All the Establishments (Punjab State Boards, Corporations and Municipal Corporations/Committees) are liable to get themselves registered on portal. Detailed Instructions and guidelines are available on the portal.

For Registration throughout the year, interested candidates $(8^{th}/10^{th}/12^{th})$ Pass and ITI/NTC holders) can use the following modes:-

- 1. Register themselves on the portal www.apprenticeshipindia.gov.in and approach the establishments selected by them for engaging them.
- Submit filled prescribed proforma along with the copies of documents for registration on portal in any Govt Industrial Training Institutes of Punjab State. Prescribed proforma for registration of candidates as apprentice is available on the web site: www.punjabitis.gov.in.

For fresher candidates who register and their contracts are generated on or before 15th April, will be allocated to the first batch of that year and those who register after this date but on or before 15th October will be allocated to the second batch of that year.

List of different designated trades for apprentice, details of registered establishment along with the opportunities and eligibility qualifications are available on the MIS application www.apprenticeshipindia.gov.in.

All the eligible candidates are invited to register themselves by above modes to acquire apprenticeship training. During the apprenticeship training the stipend will be provided to apprentice as per the NAPS-2 Guidelines.
