OFFICE MEMORANDUM

Subject: Convocation of Trainees completing the courses from ITIs - 2021-22 (two-year course), 2021-22 (one-year and six-month course)

This refers to the review meeting of Education and Skill Development chaired by Hon'ble Prime Minister on 07.05.2022 and 13.05.2022. One of the action points which emerged was to enhance aspiration for skill development. Towards that end, it has been decided to mandate regular convocations for ITI pass outs starting this year, a practice already followed in some of the states.

The convocations for the session **2021-22 (two-year course), 2021-22 (one year and six-month course)** should be organized at the individual ITI level. The examination schedule is as follows:

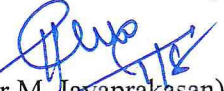

The RDSDEs/ SSDECs are expected to monitor these activities. Also, advocacy related to career pathways including apprenticeship opportunities, job melas, vertical mobility and upskilling opportunities need to be taken up at the Convocation events. For any aspect in which the guidelines do not provide clarity, the concerned ITI can take their own decision.
